

WARRANTY TERMS

WARRANTY

Numeros Motors Private Limited : Warrants that each new Electric Scooter sold by Numeros Motors or through its Authorized Dealers will be covered for warranty for a certain period of time.

Obligations : if any manufacturing defect(s) are observed in any Electric scooter within the warranty period as mentioned, Numeros Motor's only obligation is to repair or replace defective parts with new parts or equivalent at no cost to the customer for part or labour. only when Numeros Motors acknowledge that such malfunction is caused due to faulty material or workmanship during manufacturing.

Warranty Period: 3 Years from date of Invoice OR 50,000 Kms (whichever is earlier) on Diplos or it's variants. Warranty can be availed only if the Electric scooter is delivered and subsequently serviced by an authorized Numeros Motors dealer or directly by Numeros Motors Only. All the free and paid services are offered by the company are to be availed as per the frequency and schedule mentioned

Chassis frame	3 years / 75000kms
Front and Rear shock absorber	1 year / 15000kms

What's Not Covered: Painted Parts, Plastic/rubber Parts, Footrest, Bulbs, Telematics unit, Brake Pads & Shocker Seals, Wear & tear items, Throttle, Seat Assembly. Tyre Valve and Speedometer are not covered under warranty

Warranty will be null in the below cases: -

1. Used for carrying more than permissible load i.e GVW 237 Kgs.
2. Used for stunts for competitions or jumping.
3. Repaired or spare parts replaced from a non-authorized source.
4. Tempered, sealed power train components
5. Modified/ altered for any specific use other than vehicles specifications.
6. Resold to any other individual/company
7. Damaged due to natural or manmade calamities such as flooding. fire. falling objects, accidents, etc.
8. Nonfunctional due to natural wear/tear. aging. misuse, or negligence.

Note: Please note that warranty is always based on terms & conditions as defined by Numeros Motors only, warranty settlement is at the the sole discretion of Numeros Motors Private Limited.
